PAYMENT SCHEDULE

Reservations require a signed contract and a non-refundable deposit of rental cost to be applied to the rental fee to secure your date. The remaining balance is due 30 days prior to your rental date. If the balance is not paid, your event may be cancelled.

CATERERS

Buck & Johnny's provides all catering for the Glassroom for all events.

ALCOHOL

The following rules apply to alcohol service at Buck & Johnny's Glassroom:

- A certified, licensed, and insured bartender employed by one of the preferred caterers or Buck & Johnny's Glassroom approved bartending service must handle, transport, control, and serve all alcoholic beverages at your event.
- All bartenders must be certified or licensed by the state of Louisiana to serve alcohol.
- All alcohol service and consumption must comply with Louisiana state liquor laws.
- Only bartenders employed by the hired bartending service may have control of and serve alcoholic beverages at the event. The Renter and guests of the event are not allowed to serve alcoholic beverages at the event.
- During the event, Buck & Johnny's Glassroom must be available to invited guests only.
- There may be no charge of any kind for alcoholic beverages served at the event or for entry to the event.

• Buck & Johnny's Glassroom reserves the right to end alcohol service and/or the event at any time if the staff determines that any of the rules pertaining to alcohol service have not been complied with or determines that violations have occurred in connection with the service of alcohol at the event.

You agree to comply with and cause the event to comply with all of the forgoing provisions. In addition, you agree to hold harmless, defend and indemnify Buck & Johnny's Glassroom from and against any claims, injuries, causes of action, damages or expenses whatsoever resulting from or arising out of the service or consumption of alcohol at the event, or any failure to comply with the rental contract.

CAPACITY

The maximum number of guests is limited to 400 people. We can accommodate up to 300 people in the Buck & Johnny's Glassroom for a sit down dinner, and depending on your desired set up, additional dining space for a sit down dinner may be available at Buck & Johnny's Restaurant.

PARKING

Buck & Johnny's Glassroom provides parking for your guests across the street in the designated parking lot.

SMOKING

In compliance with the Louisiana Clean Air Act, Buck & Johnny's Glassroom is a non-smoking facility.

EVENT RENTALS

Additional items needed for the event must be obtained through a rental company. Any rental items you bring or have delivered are your responsibility. You are responsible to set up and take down all rental items. Please arrange to have your rental items picked up the day after your event. If next day pick up is not possible, items should be neatly stacked in the designated area for pick up no later than two days after the event. Buck & Johnny's Glassroom is not responsible for loss, theft or damage to rental items.

DECORATIONS

- Decorations must be set up and taken down in the allotted rental time.
- The area must be cleaned up and any trash removed at the end of your event.
- You are welcome to decorate as you wish; however, you must have all decorations that need hanging approved by Buck & Johnny's Glassroom.
- Candles are allowed as long as the flame is contained within glass.
- Items that are difficult to clean up such as confetti, flower petals, or streamers are not permitted.
- Sparklers and other forms of fireworks are not allowed at Buck & Johnny's Glassroom or our premises.
- The release of balloons is not permitted.
- Approval is required for all tents. Tents must be anchored by water barrels or sandbags.

CANCELLATIONS

Cancellations made prior to the event date will forfeit the initial deposit. All cancellations must be made in writing.

TRANSFER OF EVENT DATE

If you need to change the date of your event, a one-time transfer of your deposit can be made without penalty if the transfer is made 30 days or more days prior to the event date. If additional transfers are needed, and additional \$100 per transfer will apply. Within 30 days of the event, all transfers of dates will be charged \$200. All requests for transfers must be made in writing. The

new date must be within one year of the original date. Transfers between responsible parties are not allowed.

TERMINATION

Buck & Johnny's Glassroom reserves the right, at any time prior to or during your use of the facilities, to cancel your reservation and terminate your agreement in the event of emergency, physical damage to the building, or other occurrence which at the sole discretion of Buck & Johnny's Glassroom, renders the event unsuitable or unsafe for use. Such occurrences include, without limitation any of the following:

- Fire, flood, earthquake, weather damage, other casualty or act of God causing physical damage to the building or the park.
- Improvements, alterations, or repairs required by law or otherwise necessary to put or maintain the building and facilities in a safe and fully functional condition including unexpected delays in said repairs.
- Power failure, restrictive curfews, or other causes beyond the control of Buck & Johnny's Glassroom, which render the facility unfit for intended use.

In the event that your reservation and this agreement are terminated pursuant to this provision, Buck & Johnny's Glassroom will refund your rental fee. Buck & Johnny's Glassroom shall not however be held responsible for any direct, indirect, incidental or consequential damages resulting from such termination.

INDEMNIFICATION

The Renter shall hold harmless, defend and indemnify Buck & Johnny's Glassroom, its owners, employees, and agents from and against any and all claims, losses, causes of action, judgments, damages and expenses including but not limited to attorney's fees because of bodily injury, sickness, disease or death, or injury to or destruction of tangible property or any other injury or damage resulting from or arising out of (a) performance or breach of this Contract by Renter (b) Renter's use of the Buck & Johnny's Glassroom premises, or (c) any act, error, or omission on the part of the Renter, or its agents, employees, guests, invitees or subcontractors except where such claims, losses, causes of action, judgments, damages and expenses result solely from the negligent acts or omissions or willful conduct of Buck & Johnny's Glassroom, its owners, employees, or agents.
